**ORDER**

This order may be read with reference to the previous orders dated 27.12.2021 vide which the the appellant stated that he has received the information pertaining to point no. 2 and the respondent was directed to provide remaining information severing under Section 10(1) of the RTI Act the address, mobile numbers and other particulars which reveal the identity of the person.

2. The appellant Sh. Nitin Kumar Garg states that he has not received the information so far.

Information Officer, Supreme Court of India Vs. Subhash Chandra Aggarwal, regarding Right to Information Act, 2005 in which in para no. 59 of the above referred case had defined 'Personal Information' under the Right to Information Act 2005, the relevant part of the judgment is reproduced below:-

*"Reading of the aforesaid judicial precedents, in our opinion , would indicate that personal records, including name, address , Physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification , performance , evaluation reports, ACRs, disciplinary proceedings, etc. Are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded. Including that of the family members, information, relating to assets, liabilities, Income tax returns, details of the investments, lending and borrowing etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive.*

Hence, the information pertaining to point no. 3 seeks personal information which cannot be provided to him as per above said law/directions of the Hon'ble Supreme Court of India. remaining information, the respondent states that the information has been sent to the appellant through registered post. Further, the appellant has sought some time to go through the information.
