

## ORDER

- 1. This order may be read with reference to the order dated 05.01.2022 by this Bench during the previous hearing.
- 2. The case has been heard today. Lt. Col. Vijay Kumar Padwal (Retd.), appellant comes present to attend the hearing in person and states that only partial information has been provided to him by the PIO.
- 3. Neither the PIO has come present in person or through cisco webex nor he has deputed any of his representative to attend the hearing on behalf of PIO. Shri Jasbir Singh, Panchayat Secretary/PIO, Gram Panchayat Jungath is contacted on mobile phone. 5. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall

proceed to take further proceedings against him ex-parte.

6. The appellant is advised to point out deficiencies in the information supplied in writing to the

PIO. The PIO is directed to supply rectified information to the appellant, after removing the deficiencies so

pointed out by the appellant, before the next hearing and ensure to come present in person before the Bench,

bringing along the entire relevant record.
