Dr. Lakhvinder Singh, Veterinary Officer –cum- APIO along with Sh. S.S. Rana, Senior Assitant is present on behalf of Respondent/PIO.

ORDER:

This case was last heard on 25.03.2019 with the directions to the Respondent/PIO to supply the information to the Appellant and if it is not available then the Respondent/PIO was directed to file a proper reply in the form of an affidavit signed by the PIO that why the information cannot be supplied to the Appellant till date.

Today, the representative of the Respondent/PIO, Dr. Lakhvinder Singh states that information has been supplied to the Appellant and further shows an affidavit to the Court. After going through which, it was found to be ambiguous.

The Appellant requests for changing his postal address in the orders and further states that there are several deficiencies in the supplied information.

After discussing both the parties, on each and every point, I am of the view that, the Respondent/PIO is directed to supply the requisite information relating to these pending points as per the Appellant's RTI Application dated 10.01.2018. As discussed, relating to point no. 1, the Respondent/PIO is directed to supply orders by which different PIO's and APIO's have been appointed in the department of Animal Husbandry, Punjab. Relating to point no. 1 (a), the Respondent/PIO is directed to supply the attested copies of the orders by which Dr. K.P.S. Pashricha was appointed as the APIO in the department

of Animal Husbandry, Punjab. Relating to point no. 2 (b) and 2 (c), attested copies of the rules and orders. Relating to point no. 3 (a), 3 (b) and 3(c), the Respondent/PIO said that there is no said procedure, then they are directed to give this in writing in the form of an affidavit. Relating to point no. 3 (d), the Respondent/PIO is directed to clarify the reply which has been sent to the Appellant, in relating to memo bearing no. RTI/1/106/17/1008 dated 14.12.2017. Relating to point no. 5 (a) and 5 (e), the reply is still pending from the Respondent/PIO. Relating to point no. 6, and **6 (B)** the Respondent/PIO is directed to the Appellant that why the information cannot be supplied to the Appellant till date.

It has been observed that, despite of giving many opportunities still there is some information which is still pending and in the Affidavit which has been shown in the Court, today is ambiguous in nature. PIO is directed to supply the pending information to the Appellant as discussed above and he is directed to appear personally on the next date of hearing along with the postal receipt through which the information has been sent to the Appellant and further he is directed to clarify the statements i.e. "No documents are available" as it is ambiguous and does not clarify whether the information did exist with the office or not, or it did exist but has been misplaced or destroyed later on.

PIO is directed that in the affidavit they should clarify why the information is not available inspite of using vague terms and further clarify that, why the information could not be provided to the Appellant till date.

The Appellant is also directed to go through the supplied information before coming in the Court and point out deficiencies point wise, supply the copy of the same to the Respondent/PIO along with a copy to the Commission through registered post, before the next date of hearing. The Appellant is further advised to appear in person or through any of his representative on the next date of hearing.

The matter is adjourned for further hearing on 15.07.2019 at 11.00 A.M.

Both the parties to come present on next date of hearing.
