**ORDER:**

1. The above mentioned case was earlier heard by the Bench of the then Ld. SIC, Sh. Hem Inder Singh on 18.11.2021 and directions were given to the respondent PIO to furnish the certified information of point 2 within 15 days to the appellant by registered post before under intimation to the Commission and in case no information is available then he should file a proper affidavit duly notarised by the Notary. He was further directed to send the original affidavit to the appellant by registered and copy of the same be forwarded to Commission for record. He is further directed to be present on the next date of hearing through CISCO WEBEX to present the case. Matter was adjourned for further hearing on 31.01.2022.
2. The present case was allocated to the undersigned Bench on 03.01.2022 and fixed for hearing on 27.04.2022, which was further adjourned due to technical issue and fixed for today i.e. 21.07.2022.
3. In today's hearing, appellant states that information in connection with point no. 2 is still pending.
4. Respondent PIO is absent despite being aware about the date of hearing. It is observed that respondent PIO is failed to comply with the previous order of the Commission dated 18.11.2021 even after the ample time has elapsed.
5. In view of the foregoing, **respondent PIO, O/o Commissioner, Municipal Corporation, Amritsar** is directed to **Show Cause** in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
8. **Respondent PIO is directed to represent this case in person on the next date of hearing at Punjab State Information Commission, Chandigarh on 17.08.2022 at 11:00 A.M.**
9. Appellant is on liberty to attend hearing through CISCO WEBEX application (Cisco Webex Meeting Number-1582933632) on **17.08.2022 at 11:00 A.M.** Copy of the order be sent to the parties.
