ORDER

Shri Inderjit Singh, appellant filed RTI application dated 12.01.2021 and sought some information from the SPIO, O/o Addl. Deputy Director, Rural Dev. & Panchayat Department, PB., Mohali. A reply was sent to the appellant vide letter no.566 dated 11.02.2021. Not satisfied with the reply of the SPIO, the appellant filed First Appeal before the First Appellate Authority on 23.02.2021 and then Second Appeal before the Punjab State Information Commission on 02.06.2021. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today through **CISCO Webex Meetings Software**.

The appellant is present today, whereas none has appeared on behalf of the respondent. The appellant stated that no information has been provided to him by the SPIO.

I have gone through the RTI application dated 12.01.2021 and also heard the appellant. He has sought the opinion of the SPIO on some points, which does not come within the ambit of definition of 'information' as envisage U/s 2(f) of the RTI Act, 2005.

Section 2(f) of the Right to Information Act, 2005, which reveals as under :-

"(f) "information" means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force".

The information can only be sought as per the definition of 'information', but in the present case the RTI application filed by the appellant does not come within the ambit of

definition of 'information' because he has sought opinions of the SPIO on some aspects, but he has not sought any information, which is in the custody of the public authority.

I have gone through the RTI application and discussed with the appellant. The appellant is saying that he is seeking opinion of the SPIO, which comes within the definition of 'information'. He is giving stress on the point that in the definition of 'information' there is a word 'opinion', so the information seeker has right to seek 'opinion' from the SPIO.

The view of the appellant is not correct as the word 'opinion' use in the definition of 'information' is for those opinions which the public authority has got from some legal authority or any other higher authority and then that 'opinion' becomes a part of the record of the public authority and the information seeker has the right to ask for the copy of that opinion, which is held in the custody of public authority. But in the present case the appellant has not sought the copy of any opinion which is already in the custody of the Public Authority, rather he is seeking the opinion of the State Public Information Officer on the queries put to him by the appellant.

In the view of the above facts the RTI application filed by the appellant is hereby **dismissed and closed.**

They further stated that the information which was available as per the record of the Gram Panchayat, Dholan has been provided to the appellant and except that no other information is pending. They further submitted an application dated 21.09.2021 by submitting the same facts. The said application is taken in the file of the Commission.

As the SPIO has provided the information to the appellant as per the record of the Gram Panchayat, Dholan and except that no other information is pending, so the SPIO is unable to provide the same to the appellant. Hence, the present appeal case is **disposed of and closed.**
