The Bench directs the PIO to make efforts to look for the relevant records and give point-wise reply to the appellant before the next hearing. In case the relevant record is not available, the PIO is directed to file an affidavit on e-stamp paper duly signed by the PIO and attested by the Notary Public to the effect that the information sought by the appellant in AC No.3199/2022 relates back to the year 1984 and being old record, has not been traced in spite of best efforts. ORDER

1. The aforesaid appeal case was remanded back by this Bench to First Appellate Authority i.e. Assistant Estate Officer, Jalandhar Development Authority, Jalandhar vide order dated 30.06.2022. Accordingly, the notice of hearing was issued to the parties for 21.09.2022. The case has been heard today. Shri Hardev Singh, appellant comes present in person before the Bench and states that he has not received any information so far.

3. Neither the PIO has come present to attend the hearing in person before the Bench nor through Cisco Webex.

4. The Bench, on perusal of case file, observes that in the hearing in CC No.224/2022, Shri Pawan Kumar, SDO (PH)/PIO had come present on 30.06.2022 when the complaint case was remanded back to the First Appellate Authority, J.D.A. Jalandhar. A letter dated 05.09.2022 is also available in the case file whereby PUDA, S.A.S. Nagar has directed the PIO, J.D.A. Jalandhar to attend the hearing. In spite of that, the PIO has not come present to attend the hearing. This attitude of PIO is viewed adversely.

5. The PIO O/o Jalandhar Development Authority, Jalandhar is issued show cause notice to explain his absence and as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for failing to appear for the hearing and for not supplying requisite information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

6. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

7. The PIO is directed to supply requisite information to the appellant before the next hearing as also to ensure to come present in person before the Bench, failing which, the penal consequences shall follow.

8. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 31.10.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
