ORDER:

1. The RTI applications are dated **11.2.2021** and **12.2.2021** vide which the appellant has sought information **regarding GOG in Village Dakala, Ramgarh, Jalalkhera, etc.,** as enumerated in his RTI applications. First Appeals were filed with the First Appellate Authority (FAA) on **15.3.2021** and Second Appeals were filed in the Commission on **7.5.2021** under Section 19 of the Right to Information Act 2005. Notice was issued to the parties for first hearing in the Commission on **21.10.2021**.

2. Both parties are present via Video Conference from Patiala. The respondent PIO-District Head GOG, Patiala, Brig. (retd.) D.S. Grewal, submitted that a reply along with the requested information as available in his office was provided to the appellant vide Letter No. 103/DHQ-PTA Dated 7.3.2021. The appellant however, states that he has not got the information pertaining to points 3 and 4 of his RTI application.

3. The respondent PIO stated that the information requested at point no. 3 of RTI application pertains to a period of 4 years, which is far too voluminous. He offered to provide copies of specific reports if listed by the appellant. Regarding point no. 4 of the RTI application, the respondent PIO states that there are no specific attendance registers for GOGs. They do not attend any office on a daily basis and their attendance is marked by the reports they submit to various authorities including the concerned SDM, DC and District Head of the GOG.
