I have gone through the letter sent by the SPIO and it is submitted that the information sought by the appellant through point nos.1 and 2 of the RTI application is personal information and is exempted U/s 8(1)(j) of the RTI Act, 2005. The SPIO has also sent a copy of the Judgment dated 03.10.2012 passed by the Hon'ble Supreme Court of India in SLP No. 27734 of 2012 in support of the reply.

The SPIO has sent reply to the appellant vide letter dated 13.09.2021 through registered post and a period of more than one month has been passed, but the appellant has not sent any mail to the Commission regarding the reply sent by the SPIO and neither he has attended the hearing for today which means he is satisfied with the reply sent by the SPIO. So, the present appeal case is **disposed of and closed**.
