ORDER

Shri Gautam Lal, has presented the Authority Letter on behalf of Shri Raj Kumar, Appellant, which is taken on the file of the Commission.

Shri Raj Kumar, appellant has filed RTI application dated 18.07.2018 and he sought some information regarding Gram Panchayat, Korianwali, Block Fazilka.

I have gone through the RTI application and all the papers available on the file. I have heard the authorized person who is present on behalf of the appellant and also heard the PIO-cum-DDPO, Fazilka, Shri Arun Jindal. The record of Gram Panchayat, Korianwali which was in the custody of the concerned Panchayat Secretary had already been provided to the appellant, whereas some part of the record of Gram Panchayat was not handed over to the present Panchayat Secretary by the then Panchayat Secretaries Mr. Manoj Kumar, Mr. Vikas Kumar and Mr. Chander Bhan.

The office of the DDPO, Fazilka had already brought the matter to the notice of the Divisional Deputy Director, Rural Development and Panchayats, Ferozepur through letter No. 419 dated 05.11.2018 and further the Divisional Deputy Director, Rural Development and Panchayats, Ferozepur wrote letter No. 3696 dated 06.11.2018 to the Director, Rural Development and Panchayats, Punjab for taking action against the above mentioned Panchayat Secretaries, who have misplaced the concerned record of Gram Panchayat, Korianwali.

Appeal Case No. 2620 of 2017

The information which was in the custody of the concerned Panchayat Secretary had already been provided to the appellant, whereas the remaining information which has not been provided is not in the custody of the PIO, so he is unable to provide that to the appellant.

The proceedings for taking disciplinary action against the Panchayat Secretaries is pending before the Director, Rural Development and Panchayats, Punjab and whenever and whatever action will be taken against the Panchayat Secretaries, the Commission be intimated accordingly.

The PIO filed reply to the Show Cause Notice. I have heard the PIO and also gone through the reply to the Show Cause Notice. The above said facts are retreated again as reply to the Show Cause Notice. The complete information has not been provided due to the reasons mentioned above and there is no fault on the part of the PIO. So, the Show Cause Notice issued to the PIO-cum-DDPO, Fazilka is dropped and filed.

The appellant filed RTI application dated 18.07.2018. He filed First Appeal before First Appellate Authority on 17.08.2018 and then he filed Second Appeal before Punjab State Information Commission. He had come on the dates of hearings from a long distance of about 350 kilometres and he had suffered a lot. So, an amount of Rs.4,000/- be awarded as compensation in favour to the appellant and the PIO-cum-DDPO, Fazilka is directed to pay the compensation of Rs.4,000/- to the appellant and the compliance of the payment be sent to the Commission.

With the above said discussion and observation, the present appeal case is **disposed of and closed.**
