ORDER

The RTI request is dated 16.04.2019. The complaint has been received in the Commission on 20.08.2019

The appellant, Sh. Ravinder Singh, appeared in person in today's hearing.

Neither the respondent PIO of Office of Director, State Transport Department, Punjab nor any of his representative is present in today's hearing, moreover, the requisite information has also not been supplied by the respondent PIO to the information seeker even after a period of six months.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer concerned of office of Office of Director, State Transport Department, Punjab, Chandigarh, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

The PIO is also hereby given an opportunity under Section 20(1) provision, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. **A copy of this order be sent to him through registered post.**

After examining the documents placed on record, it is found that the respondent PIO through a reply vide letter no. 4253-54 dated 24.10.2019 signed by Public Information Officer of Office of Director, State Transport Department, Punjab, which has been received in the Commission vide Diary No. 21016 dated 31.10.2019, has intimated the Commission that RTI request of the appellant has been forwarded to the office of General Manager, Punjab Roadways, Batala to supply the required information to the appellant. It is taken on record.

After examining the documents placed on record, it is found that the respondent PIO through reply vide letter no. 4253-54 dated 24.10.2019 has only forwarded the RTI request of the appellant to the office of General Manager, Punjab Roadways, Batala but not transferred the same under section 6 (3) of the RTI Act to supply the required information to the appellant within the stipulated period as per provisions of the RTI Act, which reads as under :

Section 6 (3) : Where an application is made to a public authority requesting for an information,—

- (i) which is held by another public authority; or*
- (ii) the subject matter of which is more closely connected with the functions of another public authority,*

the public authority, to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer:

Provided that the transfer of an application pursuant to this sub-section shall be made as soon as practicable but in no case later than five days from the date of receipt of the application.

Accordingly, a copy of this order be sent through registered post to Director, State Transport Department, Punjab, with the advice to ensure presence of any of official of his office as a representative to represent this case on the next date of hearing to clear the facts of this case.

A copy of this order also be sent through registered post alongwith RTI request and letter no. 4253-54 dated 24.10.2019 to PIO-cum-General Manager, Punjab Roadways, Batala with the advice to ensure presence of any of official of his office as a representative to represent this case on the next date of hearing to clear the facts of this case.

The case is **adjourned to 15th January, 2020 (Wednesday) at 11:00 A. M.**
