2. Sh. I have received the compensation awarded by the Court of amount 2500/- having no. 519 dated 20.11.2019 in the name of appellant in which the father's name of appellant is wrongly given as Bachitar Singh instead of Bachitar Singh.*"

4. Demand draft of compensation i.e. Rs. 2500/- is handed over to Sh. Iqbal Singh (representative of the appellant). The perusal of the file shows that during the last hearing, Bailable warrant was issued to Sh. Gurpayar Singh, PIO, o/o Naib Tehsildar, Sub Tehsidlar Mullanpur Dakha, Distt. Ludhiana to appear before the Commission. But today again he has not bothered to appear before the Commission. This shows he has no regard for the orders issued by the Commission.

5. It is very strange that neither he has filed reply to the show cause notice u/s 20 (1), nor availed himself of the opportunity for personal hearing afforded to him u/s 20 (1) proviso there to nor he has bother to report compliance. This adamant attitude cannot be adopted with impunity.

5. Deputy Commissioner, Ludhiana is hereby directed to take disciplinary action be taken against the said Sh. Gurpayar Singh, PIO, o/o Naib Tehsildar, Sub Tehsidlar Mullanur Dakha, Distt. Ludhiana under section 20(2) of the RTI Act 2005 since he has persistently not furnished information within the time specified and has knowingly denied the request for information and obstructed the furnishing of information. It is, therefore, recommended in terms of section 20 (2) that disciplinary action be taken against the said State Public Information Officer i.e. Sh. Gurpayar Singh, PIO, o/o Naib Tehsildar, Sub Tehsidlar Mullanur Dakha, Distt. Ludhiana under the Service rules applicable to him.

Deputy Commissioner, Ludhiana is directed to send compliance report before the next date of hearing.

ORDER

This order may be read with reference to the previous order dated 15.10.2019 vide which a show cause notice was issued to the PIO, o/o BDPO, Ludhiana-1, Ludhiana.

2. Today the appellant Sh. Amar Singh states that no information has been given to him so far.

3. Respondent is absent today.

4. The perusal of the file shows that in this case, application for information was filed on 27.03.2019 but after lapse of more than seven months, no information has been given to the appellant so far. It is, thus apparent from the response of the respondent-PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.

5. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 2500/- (Rupees Twenty Five hundred only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer before the next date of hearing.

6. In this case, it is derived that the respondent-PIO is intentionally delaying the supply of information and he has no respect for the orders of the Commission to be present, either himself or through his representative in the court.

7. In view of the defying attitude of the respondent-PIO neither attending the court nor submitting any explanation for the delay in supplying the information within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the imposition of penalty amounting to Rs. 25000/- (Rupees Twenty five thousand only) on the PIO. Therefore, taking a lenient view, I impose a penalty of **Rs. 2500/- (Rs. Twenty Five hundred only)**. The Drawing and Disbursing Officer of the office of DDPO, Ludhiana is directed to deduct the amount of penalty of Rs. 2500/- from the salary of PIO, o/o BDPO, Ludhiana-1, Ludhiana and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-
