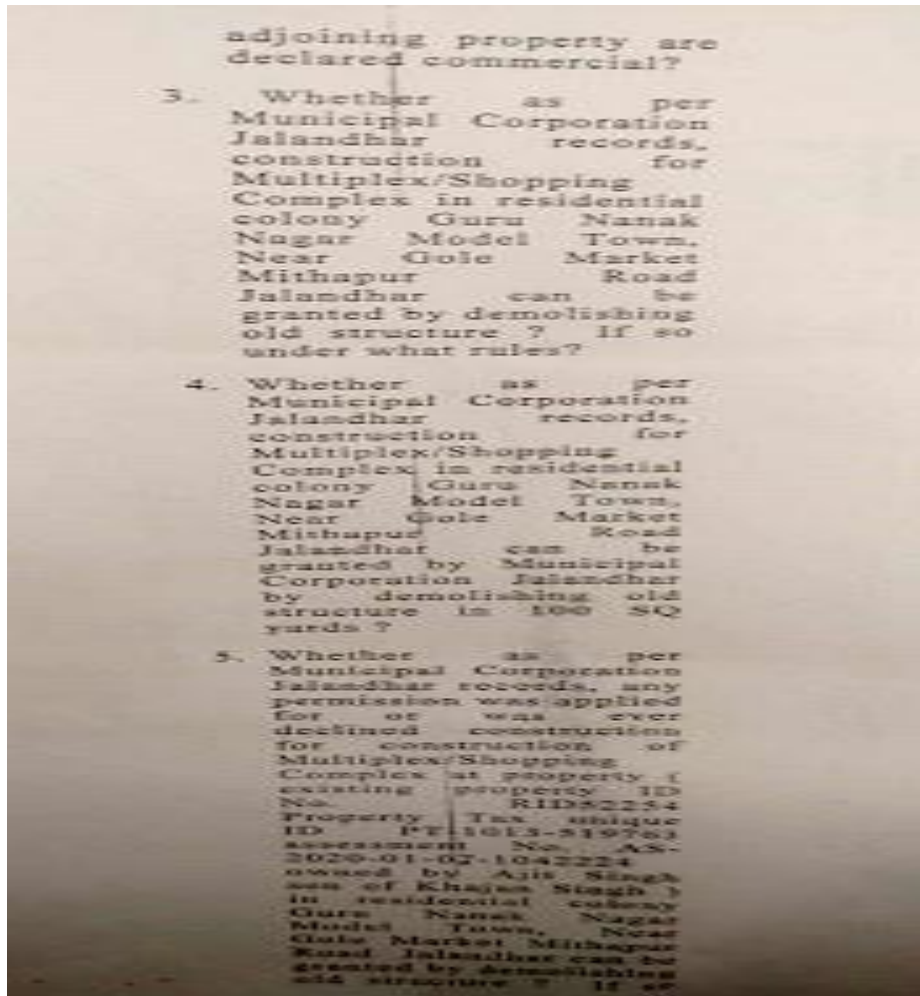

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **4.8.2021** and Second Appeal was filed in the Commission on **8.6.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **21.10.2022**.

2. The appellant is absent without intimation. At the last hearing on 21.10.2022, the respondent PIO-cum-ATP, Smt. Pooja Mann was directed to appear in person along with original record as sought in the RTI application along with duly attested copies of the same. Smt. Pooja Mann, is present and states that she has made efforts to locate the old record pertaining to the building cited in the RTI application but she has been unsuccessful in doing so, since as per the owner of the building, the said building was constructed before the year 1992, when the Jalandhar Municipal Corporation came to in existence.

3. It is also noted that as per the respondent, the appellant is a tenant in the cited building and he is currently in court in connection with eviction proceedings initiated by the owner of the cited building. The respondent PIO has further submitted an affidavit clearly stating that information regarding cited building, as available in record of Jalandhar Municipal Corporation, has also been supplied to the appellant in Appeal Case No. 308 of 2021 which was disposed of by the Ld. SIC Sh. Anumit Singh Sodhi.

4. The Commission notes that the RTI application is in the present case and that in Appeal Case No. 308 of 2021 are very similar and it is evident that the appellant has submitted more than one RTI application and Second Appeal to obtain the same information, regarding which, the respondent PIO has already furnished an affidavit.

5. This Appeal Case is accordingly **Disposed of**.
