

#### ORDER:

The appellant, through an RTI application dated 23.02.2021 has sought information on eight points regarding the existence of a rule under which the National Health Mission vide letter dated 20.11.2020 has recommended action against the appellant without giving an opportunity of hearing – a copy of justification filed for the delay in the release of the budget which resulted in the release of salary for April as well as the rule under which acquitted and other information as enumerated in the RTI application from the office of National Health Mission, Pb Chandigarh. The Commission was of the view that since the appellant has had to suffer undue inconvenience in getting the information, it is a fit case for awarding compensation to the appellant u/s 19(8)(b) of the RTI Act. Hence, the current PIO-DFSC, Pathankot, was directed to pay an amount of **Rs.5000/-** via demand draft as compensation to the appellant for the loss and detriment suffered by him on having to file the appeals and not getting information on time and submit evidence for having made the payment of compensation amount to the appellant.

#### Appeal Case No. 1910 of 2021

Further, it was observed that Shri Sukhjinder Singh, DFSC-cum-PIO Pathankot (07.11.2019 to 05.04.2021) was the PIO when the RTI was filed (22.12.2020), and there was prima facie evidence that the application was not attended to as per the RTI Act. One last opportunity was given to Shri Sukhjinder Singh, the then DFSC-cum-PIO now posted at Gurdaspur, to submit a reply to show cause notice before the next date of hearing.

The current PIO was directed to provide the sought information within a week.

#### Hearing dated 21.11.2022:

The case has come up for hearing today through video conferencing at DAC Sri Mukatsar Sahib/Pathankot. The respondent present pleaded that the information has already been provided to the appellant, and the compensation amount has also been paid to the appellant vide demand draft dated 16.08.2022 with a copy to the Commission.

The appellant is absent and, vide letter dated 25.08.2022, has informed that he has received the compensation amount by way of a demand draft.

Sh.Sukhjinder Singh has also sent a reply to the show cause notice, which has been taken on record.

Since the information has been provided and the compensation has been paid, no further interference from the Commission is required. The case is **disposed of and closed.**

#### ORDER:

The appellant through an RTI application dated 04.09.2020 has sought a copy of the main file of the procurement & Storage branch along with all noting (50 pages) of the first chief crop in year 2011-12 relating to Baba Khazan Das Agro Industries, district Ludhiana, from the O/o MD, Punjab State Civil Supplies Corporation Ltd. The appellantthe filed first appeal with the first appellate authority on 31.01.2021 which took no decision. The appellant filed a second appeal in the Commission on 12.05.2022 under section 19 of the RTI 2005.

The case first came up for hearing on 20.07.2022. The appellant claimed that the PIO had not supplied the information.

The respondent pleaded that the requisite information was being traced, and the same will be supplied shortly. The respondent further requested to adjourn the case to a short date.

The appellant agreed to the plea of the respondent. The PIO was directed to supply complete certified information to the appellant within 15 days of the receipt of this order.

On the date of the last hearing on **04.10.2022, the** appellant claimed that the PIO has not supplied the information.

The respondent pleaded that due to some reservations by the department in parting with the information, the information was not provided.

Since the order to provide the information had already been passed by this bench on 20.07.2022 and the PIO's reluctance to part with the information even after orders have been passed to provide the information was prima-facie evidence of PUNSUP trying to defy the orders of the commission and thus stonewalling the information.

#### Appeal Case No. 2381 of 2022

The Commission having taken a serious view of this, issued a **show cause notice to** the PIO under section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time and for not complying with the order of the Commission and directed to file reply on an affidavit. The PIO was directed to provide information to the appellant within ten days of the receipt of the order and send a compliance report to the Commission.

### **Hearing dated 21.11.2020:**

As per the respondent, the information has been provided to the appellant vide letter dated 14.11.2022.

The appellant is absent and, vide letter received in the Commission on 18.11.2022, has informed that he has received the information and is satisfied with the provided information.

The PIO has also submitted a reply to the show cause notice, which has been taken on the record. Since the information has been provided and the appelant is satisfied with the provided information and does not want to pursue the matter further, the case is **disposed of and closed.**
