ORDER

The RTI application is dated 20.2.2021 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 23.3.2021 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 21.6.2021.

2. The appellant has sought the following information:-
