1. The appellant filed appeal in the Commission dated 04.10.2018. Accordingly the case was fixed for hearing today.
2. Representative of the appellant, Sh. Amrit Pal Singh states that requisite information is still pending from the respondent PIO.
3. Neither the respondent PIO is present for today's hearing nor did he file any reply in this regard, which shows that no regard to the Notice of the Commission as well as of the RTI Act.
4. After hearing the representative of the appellant, Sh. Amrit Pal Singh and examining the case file, another opportunity is given to the respondent PIO to represent this case in person on the next date of hearing along with directions to supply the reply/information as per RTI application of the appellant before the next date of hearing, failing to which action as per RTI Act will be initiated against him. A copy of this order be sent to him through **registered post** for his ready reference.
5. Matter is adjourned for further hearing on **20.02.2019 at 11:30 A.M.**
