After hearing both the parties and examining the case file, it is observed that the present case i.e. Complaint Case No. 1045 of 2018 was disposed of & closed by the bench of undersigned vide Order dated 13.05.2019 on the assurance of the respondent, Sh. Gagandeep Singh that he will supply the attested copy of requisite information to the appellant within ten days from 13.05.2019 but

respondent PIO had not complied with the order of the Commission and complainant approached

the Commission dated 13.05.2019. Accordingly this case was fixed for hearing on 21.08.2019.

5. On hearing held on 21.08.2019, respondent PIO was absent without any intimation and he

attitude and irresponsible behavior of the respondent PIO concerned, compensation amounting Rs.

1,000/- was awarded to the complainant. One more opportunity was given to the respondent PIO to

supply the attested copy of the requisite information and compensation cheuqe from the account of

Public Authority to the appellant along with directions to represent this case and matter was

adjourned for further hearing on 11.09.2019

6. On hearing held on 11.09.2019, respondent PIO was absent continuously second time

without any intimation to the Commission nor did he comply with the order dated 13.05.2019.

Compensation was enhanced to Rs. 1,500/- from Rs. 1,000/-. A last opportunity was given to the

respondent PIO to comply with the previous order of the Commission dated 13.05.2019 and supply

the compensation cheque amounting Rs. 1,500/- to the complainant and matter was adjourned for

further hearing today i.e. 22.10.2019 but till date respondent PIO failed to represent this case as well

as he failed to comply with the previous order of the Commission dated 13.05.2019.

7. Due to continuous absence of the PIO despite of due notice(s) and directions under RTI

Act, the concerned PIO O/o MTP, Amritsar i.e. Sh. Jaspal Singh, PIO, O/o S.U.S. Adarsh

Sen. Sec. School, Balad Khurd (Sangrur) has not complied with the orders of the undersigned,

therefore in exercise of powers vested in the Commission under section 18(3) of RTI Act read

with relevant provisions of Civil Procedure Code, I here by direct that Bail-able Warrant be

<u>issued for appearance of Sh. Jaspal Singh PIO, S.U.S. Adarsh Sen. Sec. School, Balad Khurd (Sangrur)</u> to produce the record and give evidences pertaining to RTI queries. <u>A copy of Standard Co</u>

this order shall be endorsed to The Senior Superintendent of Police, Sangrur for execution of

the bail-able warrant to Sh. Jaspal Singh.
