"The appellant had sought information about the cases of penalty imposed against defaulters under GST Act w.e.f. 01.01.2018 to 12.04.2018.

Sh. Sushil Kumar, ETO appearing on behalf of the respondents reiterates the stance taken by them and conveyed to the Commission vide memo dated 03.12.2018. The defence of the respondent is that the sought for information is a 'personal information' of the third parties whose number is in legions. To follow the procedure under Section 11 of the RTI Act for such number of people shall divert their resources disproportionately. They further say that information sought has no relation to the public interest and is exempted from revelation under Section 8(1) (j) of the Act.

They have also taken the plea that the second appeal is a time-barred having been filed after 90 days of the order passed by the First Appellate Authority. The FAA had disposed of his appeal having afforded him a couple of opportunities by upholding the aforesaid position of the PIO. An opportunity is afforded to the appellant to comment on the position taken by the respondents failing which it shall be presumed that he has nothing to say on the matter and the appeal shall be decided as per record on file."

ORDER

The following order was made by this forum on 06.12.2018:

"The information sought pertains to various activities of gram panchayat over a period of last ten years. Obviously, it shall entail massive record. The Commission finds that providing of certified copies of the entire record shall not only divert its resources but it shall be an onerous task for the Public Authority too. The Commission directs the respondents to allow him the inspection of the record at a mutually agreed date and time which shall be adhered to scrupulously and provide him certified copies not beyond one hundred pages as identified by him. The limit can be ignored if he convinces the Commission that the public interest shall not be served within the above said number of copies."

The case has come up today. The appellant is absent. The respondents say that despite various communications to him he has failed to turn up and inspect the record. In the interest of natural justice another opportunity is afforded to the appellant to put forward his point of view if any failing which it shall be presumed that he has nothing to say on the matter and the appeal shall be disposed on merit on the basis of the record available on file.
