2. The appellant is absent today, however, his representative appears in the court and states that as per directions of the Commission on the previous date of hearing, no information has been supplied by the Respondents till date.

3. On transfer of Shri Ashok Kumar, EO-cum-PIO, MC, Jaitu, to EO, MC, Jagraon, recently Shri Gurdas Singh has taken over as EO, MC, at Jaitu, is present in the court.

4. Shri Ashok Kumar, the then EO-cum-PIO, MC, Jaitu, as informed by the present EO-cum-PIO, MC, Jaitu, was relieved from Jaitu on 06.01.2020. When he was directed in the court to submit an Affidavit duly attested by the Notary, he argued in the court that he cannot give affidavit and he will submit only "self-declaration". Therefore, viewing the delaying attitude of Shri Ashok Kumar, the then respondent-PIO, a Show Cause Notice under Section 20(1) of the RTI Act 2005, is issued to him to explain the reasons through a duly attested affidavit as
