ਉਪਰੋਕਤ ਵਿਸ਼ੇ ਦੇ ਸਬੰਧ ਵਿੱਚ ਬੇਨਤੀ ਹੈ ਕਿ ਸ੍ਰੀ ਹਰਨਾਮ ਦਾਸ ਹਾਊਸ ਨੰਬਰ 3165 ਡੀ, ਸੈਕਟਰ 40 ਡੀ ਚੰਡੀਗੜ੍ਹ ਵੱਲੋਂ ਆਪਣੀ ਦਰਖਾਸਤ ਮਿਤੀ 22-03-2019 ਰਾਹੀਂ ਗਰਾਮ ਪੰਚਾਇਤ ਖਲੀਲ ਦੇ ਸਾਲ 2013-2014 ਤੋਂ ਸਾਲ 2017-2018 ਤੱਕ ਅਤੇ ਹੋਰ ਦਰਖਾਸਤਾਂ ਰਾਹੀਂ ਵੱਖ-ਵੱਖ ਰਿਕਾਰਡ ਦੀ ਮੰਗ ਕੀਤੀ ਗਈ ਸੀ। ਜਿਸ ਸੰਬੰਧੀ ਉਸ ਵੱਲੋਂ ਸ੍ਰੀ ਸੁਰੇਸ਼ ਅਰੋੜਾ ਕਮਿਸ਼ਨਰ ਜੀ ਪਾਸ ਕੰਪਲੇਟ ਨੰਬਰ 2535, 2538, 2539, 2540 ਆਫ 2019 ਦਾਇਰ ਕੀਤੀਆਂ ਗਈਆਂ ਸਨ। ਇਸ ਸੰਬੰਧ ਵਿੱਚ ਉਸ ਨੂੰ ਸ੍ਰੀ ਯੂਸਫ ਮਸੀਹ ਪੰਚਾਇਤ ਸਕੱਤਰ -ਕਮ ਪੀ.ਆਈ.ਓ ਗਰਾਮ ਪੰਚਾਇਤ ਖਲੀਲ ਵੱਲੋਂ ਪੱਤਰ ਨੰਬਰ 101 ਮਿਤੀ 14-10-2019 ਰਾਹੀਂ ਰਿਕਾਰਡ ਦੀਆਂ 336 ਕਾਪੀਆਂ ਦਰਖਾਸਤ ਕਰਤਾ ਦੇ ਵਕੀਲ ਨੂੰ ਕਮਿਸ਼ਨਰ ਜੀ ਦੇ ਸਾਹਮਣੇ ਹੀ ਦੇ ਦਿੱਤੀਆਂ ਗਈਆਂ ਸਨ। ਇਥੇ ਇਹ ਵੀ ਦੱਸਣਯੋਗ ਹੈ ਕਿ ਦਰਖਾਸਤ ਕਰਤਾ ਦੇ ਬਿਹਾਵ ਤੇ ਹਾਜ਼ਰ ਹੋਏ ਸ੍ਰੀ ਰਣਜੀਤ ਸਿੰਘ ਵੱਲੋਂ ਵੀ ਗਰਾਮ ਪੰਚਾਇਤ ਖਲੀਲ ਦਾ ਸਾਲ 2012-13 ਤੋਂ ਹੁਣ ਤੱਕ ਲੱਗਭੱਗ ਮੁਕੰਮਲ ਰਿਕਾਰਡ /ਦਸਤਾਵੇਜ਼ ਸੀ.ਸੀ ਨੰਬਰ 804 ਆਫ 2016, ਸੀ.ਸੀ ਨੰਬਰ 1389 ਆਫ 2016, ਸੀ.ਸੀ ਨੰਬਰ 1825 ਆਫ 2016, ਸੀ.ਸੀ ਨੰਬਰ 1884 ਆਫ 2016, ਸੀ.ਸੀ ਨੰਬਰ 5983 ਆਫ 2017, ਸੀ.ਸੀ ਨੰਬਰ 1726 ਆਫ 2017, ਸੀ.ਸੀ ਨੰਬਰ 922 ਆਫ 2017, ਸੀ.ਸੀ ਨੰਬਰ 198 ਆਫ 2017 ਆਦਿ/ਵੱਖ-ਵੱਖ ਦਰਖਾਸਤਾਂ ਰਾਹੀਂ ਪ੍ਰਾਪਤ ਕੀਤੇ ਜਾ ਚੁੱਕੇ ਹਨ। ਉਕਤ ਕੰਪਲੇਟ ਕੇਸ ਵਿੱਚ ਪ੍ਰਾਪਤ ਕੀਤੇ ਗਏ ਰਿਕਾਰਡ ਵਿੱਚ ਦਰਸਾਏ ਗਏ ਸਮੇਂ ਦੌਰਾਨ ਪ੍ਰਾਪਤ ਗਰਾਂਟਾਂ ਦੇ ਸ਼੍ਰੇਕਸ਼ਨ ਪੱਤਰ, ਹਦਾਇਤਾਂ ਅਤੇ ਭੇਜੇ ਗਏ ਵਰਤੋਂ ਸਰਟੀਫਿਕੇਟਾਂ ਦੀਆਂ ਨਕਲਾਂ ਵੀ ਸ਼ਾਮਿਲ ਹਨ। ਜਿਸ ਕਾਰਨ ਸੀ.ਸੀ ਨੰਬਰ 647 ਆਫ 2019 ਵਿੱਚ ਰਣਜੀਤ ਸਿੰਘ ਦੇ ਗਰਾਮ ਪੰਚਾਇਤ ਸੈਂਤਪੁਰ ਅਤੇ ਖਲੀਲ ਸਬੰਧੀ ਕੋਈ ਅਪੀਲ ਦਾਇਰ ਕਰਨ ਤੇ ਰੋਕ ਲਗਾਈ ਗਈ ਸੀ। (ਕਾਪੀ ਨੱਥੀ ਹੈ)।

ਹੁਣ ਸ੍ਰੀ ਰਣਜੀਤ ਸਿੰਘ ਵੱਲੋਂ ਹਰਨਾਮ ਦਾਸ ਰਾਹੀਂ ਉਸੇ ਹੀ ਰਿਕਾਰਡ ਦੀ ਦੁਬਾਰਾ ਮੰਗ ਕੀਤੀ ਜਾ ਰਹੀ ਹੈ। ਜਦ ਕਿ ਸ੍ਰੀ ਹਰਨਾਮ ਦਾਸ ਕਦੇ ਵੀ ਉਕਤ ਅਪੀਲ ਦੇ ਸੰਬੰਧ ਵਿੱਚ ਹਾਜ਼ਰ ਨਹੀਂ ਹੋਇਆ। ਸ੍ਰੀ ਰਣਜੀਤ ਸਿੰਘ ਵੱਲੋਂ ਇੱਕ ਹੀ ਸੂਚਨਾ ਕੇਵਲ ਪ੍ਰੇਸ਼ਾਨ ਕਰਨ ਲਈ ਅਲੱਗ-ਅਲੱਗ ਵਿਅਕਤੀਆਂ ਰਾਹੀਂ ਮੰਗ ਕੇ ਇਸ ਦਫਤਰ ਦੇ ਸੀਮਿਤ ਸਾਧਨਾਂ ਉੱਪਰ ਬੇਲੋੜਾ ਬੋਝ ਪਾਇਆ ਜਾ ਰਿਹਾ ਹੈ।

3. Representative of the appellant, Sh. Ranjit Singh states that he is not satisfied with the decision of bench of undersigned.

4. After hearing both the parties and examining the documents placed on record, it is observed that this case was filed by the appellant, Sh. Harnam Dass but he never appeared before the bench of undersigned and nobody was present on his behalf on the hearings held on 15.10.2019 and 18.11.2019.

It is also observed that RTI application is vague in nature as no time period is mentioned in RTI application and despite of it the requisite information has already been supplied to the representative of the appellant in other cases on 14.10.2019 before the Hon'ble CIC. Therefore, no cause of action is required in this case. Hence, this instant appeal case is **disposed of & closed**.
