

The respondent SPIO, represented by Ashish Jain, SA, in a reply sent to the appellant vide Letter No. 202117478 dated 15.01.2021, claimed exemption from disclosure contending that the information requested pertained to "third parties". The reply of the respondent is however not satisfactory.
- 4. This Commission directs the SPIO to submit a written, point-wise reply to the RTI application wherein he should site specific provisions of the RTI Act, 2005 if he seeks exemption from disclosure of any information. The reply must be sent to the appellant within 10 days with a copy to the Commission.
