2. Respondent, Sh. Rajesh Saini stated that the sought information cannot be supplied to the appellant as it is third party information. He further added that the third party Ms. Gurpreet Kaur had a submission in writing , regarding the information that it should be not be disclosed , the relevant portion of which is reproduced below:

3. Keeping in view the facts of the case the commission transpires that the disclosure of such information is not in the public interest as the appellant has asked for the information for promotion of his personal interest. Therefore, the PIO is justified in denying the information sought, u/s 8(1)(j) of the Act.

**Section 8(1)(j) of RTI Act, 2005** states as

“Notwithstanding anything contained in this act , there shall be no obligation to give any citizen information which relates to personal information the disclosure of which has no relationship to any public activity or interest , or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information officer or the State Public Information Officer or the appellate authority , as the case may be , is satisfied that the larger public interest justifies the disclosure of such information.”

The case is disposed of and closed accordingly.
