5. During deliberations on the instant complaint case, the Bench observes

that the complainant Shri Lakhvinder Singh is not fully aware of the contents of RTI

application and has also not approached the First Appellate Authority. It is directed that

First Appellate Authority will hear the case as per provisions of RTI Act and provide the

information to the complainant.

6. It must be noted that there is an alternate and efficacious remedy of First

Appeal available under Section 19(1) of the RTI Act. It appears that the complainant has

failed to avail the same in the instant complaint case. The Bench observes that the

complainant must be given an opportunity to avail of the above said remedy.

7. In view of the aforesaid, the instant matter is remanded to the First

Appellate Authority i.e. Er. Jasveer Singh, Chief Engineer, Enforcement, PSPCL, Patiala.

The Commission hereby directs the FAA to treat the copy of the Complaint (enclosed

herewith) as the First Appeal and decide the matter in accordance with the provisions of

the RTI Act after giving all concerned parties an opportunity to be heard. In case, the

complainant is not satisfied with the decision of the First Appellate Authority (FAA), he is

at liberty to file second appeal with Punjab State Information Commission in accordance

with the provisions of the RTI Act, 2005.

8. In view of the above, the instant complainant case is disposed off and
