APPEAL CASE NO. 5061 OF 2021

On not receiving information from the PIO or on filing First Appeal with the First Appellate Authority (hereinafter FAA) on 23.08.2021, the Appellant filed Second Appeal in the Commission on 08.11.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 21.02.2022.

During the hearing dated 21.02.2022, the Appellant stated that incomplete information had been provided to him whereas the PIO was absent. Adjourned for 22.03.2022.

The case is fixed for today. The Appellant reiterates his earlier version that incomplete information has been provided to him while the Respondent states that available information has already been provided to him vide letter no. 4829/R.T.I., dated 19.08.2021 and he further states that appellant was asked that if he has not satisfied with the information, he can approach the First Appellant Authority but he did not do so.

After hearing both the parties and perusal of the case file, this case is hereby, remanded back to the First Appellate Authority O/o Director, Vigilance Bureau, Punjab, Vigilance Bhawan, Sector – 68, S.A.S Nagar (Mohali), who is directed to decide the RTI application afresh as per provisions of the RTI Act, 2005.
