ORDER

1. This order may be read with reference to the previous order dated 04.03.2021 vide which respondent PIO was directed to supply the proper reply/information to the appellant in writing before the next date of hearing with a copy to the Commission and matter was adjourned for today i.e. 22.04.2021.
2. In today's hearing, representative of the appellant, Advocate, Varun Bansal states that SHO called the appellant to appear in person and submit documents on 06.07.2021 in connection with written complaint filed by PUDA against the appellant but complaint was filed by PUDA on 17.07.2021. He further mentioned that respondent PIO supplied the earlier supplied information again which is not related with the demanded information in connection with complaint dated 06.07.2020.

He also added that on 06.07.2020, appellant visited the SHO office and demanded to show the written complaint filed by PUDA against him but complaint was not shown/supplied to him. Accordingly, appellant filed RTI application dated 16.07.2020 to the respondent's office to collect the copy of complaint and RTI application was received in the respondent's office on 17.07.2021. On the same date i.e. 17.07.2020, written complaint was filed by the PUDA against the appellant.
3. On this, respondent, Sh. Karanjeet Singh requested for an adjournment in this case through telephonic call made by the undersigned bench during the hearing.
4. After hearing the representative of the appellant and examining the case file, I observed that appellant demanded the following information through RTI application dated 16.07.2020

Sub: Application under RTI act 2005
R/Sir,

I Balwinder Singh R/o Bathinda is hereby going to submit my application under RTI act 2005. I received a call from Ravinder Sidhu SHO, Civil Lines Police station on my mobile phone on dated 06th July 2020 at 5:14pm evening in which he asked me to present before him along with the documents related to my land which is situated in Dhobiana Basti. Upon asking the same, he told me that PUDA has filed a complaint against me, that's why you have to produced the documents before me. He also said that, upto production of record, you will not do any type of construction over your land upto my next orders. The said call & conversation has been auto recorded in my mobile. Now, I need the information related to the complaint which had been filed by the PUDA against the said land before SHO, for which the said SHO was talking.

1. Please provide me copy of the above mentioned said written complaint which has been filed by the PUDA before the SHO, Police station Civil Lines Bathinda.
2. Please provide me details on what basis, the concerned SHO has directed me to produce the documents of said land before him (as per the recorded call/conversation).
3. Please provide me copy of rules under which the SHO can interfered or inquired the matter of land i.e civil matter without any written complaint filed by the concerned authorities like PUDA.

It is also observed that no information has been supplied to the appellant till date by the respondent PIO. A final opportunity is afforded to the respondent PIO to supply the information within 07 days from the date of receipt of this order under intimation to the Commission. He is also directed to appear before the Commission on the next date fixed.

Respondents to note that in case no one comes present on their behalf on the next date fixed, failing which penal consequences shall follow. A copy of this order be sent to Sh. Karanjeet Singh (SHO) through registered post for his ready reference.

ORDER

1. This order may be read with reference to the previous order dated 10.03.2021 vide which respondent PIO was not present and after examining the case file, it was observed that requisite information has been sent through registered post to the appellant dated 05.03.2021 comprising 62 pages (in connection with point no. 1 to 5 as per RTI application) and reply in connection with point no. 6 was also sent to the appellant.

Surajpreet Singh on behalf of the respondent stated that requisite information has already been supplied to the appellant on March 5th, 2021 comprising of 62 pages in connection with point no. 1,2,3,4 and 5. He added that reply in connection with point no. 6 has also been supplied to the appellant. He further mentioned that appellant was called to inspect the official record through letter dated 11.11.2020 but appellant denied to do so.
