So a last and final opportunity was granted to the appellant that he should personally come present before the Bench on the next date of hearing and in case he would not come present then the case will be heard and decided in his absence on the basis of information provided to him by the PIO. But inspite of direction issued to him he has not come present to state that whether he is satisfied with information or not.

Shri Ravinder Pal Singh, APIO has come present and he submitted a copy of letter No. 931/22-E dated 21.05.2019 along with detail of pages amounting to 539 pages provided to the appellant and a receipt dated 19.04.2019 duly signed by Shri Som Chand, appellant through which he received the copies of information. All the papers are taken in the file of the Commission.

As the PIO has provided 539 pages of sought for information to the appellant and the appellant has signed the receipt that he has received the information, so the present appeal case is **disposed of and closed**.
