



This is a complaint case, therefore, at this juncture, it is relevant to invite the attention of the complainant to the Judgment of the Hon'ble Supreme Court of India rendered on 12.12.2011 in Civil Appeal Nos.10788 of 2012 (arising out of SLP © No.32768/2010 un para 31 whereof, it has been held that while entertaining a complaint case under section 18 of the RTI Acy, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of the first appeal is available to the complainant under section 19(1) of the RTI Act, 2005, which has not been availed in the instant case. The complainant is advised to approach the first appellate authority in this behalf.

I am marking this case to First Appellate Authority along with a copy of the RTI application to treat this as the first appeal of the complainant and decide the case within 45 days.
