**ORDER**

Shri Kuldeep Singh Khaira appellant filed RTI application dated 27.04.2011 before the PIO, then he filed First Appeal before the First Appellate Authority on 26.06.2011 and after that he filed Second Appeal before the Central Information Commission.

The Central Information Commission vide Order dated 17.09.2018 sent the appeal case to the Hon'ble Chief Information Commissioner, State Information Commission, Punjab for hearing of the appeal case regarding the RTI application dated 27.04.2011.

I have minutely gone through the RTI application dated 27.04.2011 and heard both the parties and discussed about the sought for information. Some information was provided to the appellant by the PIO vide letter no.60160 dated 24.11.2011 except the implementation of Sections 4, 25 and 26 of the RTI Act, 2005.

The appellant admitted that except the implementation of Sections 4, 25 and 26 of the RTI Act, 2005 he has received the whole information through letter no. 60160 dated 24.11.2011.

I have gone through the case file. There is a Resolution No.212 dated 21.02.2019 passed by the Executive Committee, Shiromani Gurudwara Prabandhak Committee, Amritsar and it is resolved in the Resolution to computerized the record of

Shiromani Gurudwara Prabandhak Committee and upgrade the system software concerning the matters of Shiromani Gurudwara Prabandhak Committee.

I have gone through letter no.60007 dated 09.04.2019 and also gone through the copy of letter no.60052 dated 22.06.2019 written by the PIO to Shri Kuldeep Singh Khaira, appellant. The PIO wrote letter dated 22.06.2019 to the appellant that there is a website 'info@sgpc.net' and the service rules, laws and by laws regarding the employees of Shiromani Gurudwara Prabandhak Committee is available on the said website and he further submitted that to computerized the record it will take time, but the efforts are going on to put up the whole record of Shiromani Gurudwara Prabandhak Committee on the website.

The appellant agitated on this point and he submitted before the Bench that a direction be issued to the officials of Shiromani Gurudwara Prabandhak Committee that compliance of Section 4 and other provisions of the RTI Act, 2005 be made time bound.

I have heard the appellant and the PIO on this issue and after going through the papers available in the file, filed by the appellant as well as by the PIO, the officials particularly the Secretary, Shiromani Gurudwara Prabandhak Committee, Amritsar is directed that compliance of Section 4 and other provisions of the RTI Act, 2005 be put up on the website of Shiromani Gurudwara Prabandhak Committee probably within a period of one year before 31.08.2020 and compliance report be sent back to the Commission that the Shiromani Gurudwara Prabandhak Committee, Amritsar has created a website for the implementation and computerization of the record related with the RTI Act, 2005 as provided U/s 4 of the RTI Act.

So, with this observation the present appeal case is **disposed of and closed**.

**O R D E R**

I have gone through the Order dated 23.07.2019. The information had already been provided to the appellant by the PIO as was sought by her through her RTI application dated 03.10.2018. The appellant was not satisfied with the information related with para nos.4, 7 and 13 of the RTI application.

Today at the time of hearing the appellant submitted a list of deficiencies regarding para nos. 4, 7 and 13 of the RTI application that which part has not been provided as was sought by her through her RTI application. The list of deficiencies is provided to the PIO, Smt. Pallavi Chhabra with a direction to her that in case the information regarding the deficiencies is available in her office that be provided to the appellant and in case no information is available regarding the deficiencies then submit accordingly on the next date of hearing that the information had already been provided and no other information sought by the appellant regarding para nos. 4, 7 and 13 is available in the office of the PIO, so she is unable to provide it to the appellant.

A Show Cause Notice was issued to Smt. Pallavi Chhabra, PIO-cum-DM that why you have not provided the complete information to the appellant and so why you may not be penalized under the provisions of the RTI Act, 2005 and why not compensation be awarded to the appellant.

The PIO today filed reply to the Show Cause Notice through affidavit dated 22.08.2019 and through letter no.1795 dated 16.08.2019, which was received in the office of the Commission on 19.08.2019 diarized vide no.15803.
