2. The Complainant states that he has not received any information from the Respondent.
3. Sh Bhoora Ali, HC is appearing on behalf of the Respondent today. He has filed a letter from the APIO Ms Gurpreet Kaur O/o Respondent stating as under:-

4. After hearing both the parties and perusing the case file, it is ascertained that, on the previous date of hearing, the Complainant had identified the information required and Ms Gurpreet kaur, EO had assured the Bench that the information would be provided to the Complainant, before the next date of hearing. However, till date the same has not been

provided even though there has been a delay on the part of the Respondent-PIO to transfer the RTI application of the Complainant within the prescribed time limit for such transfer, under the RTI Act. The Respondent-PIO has failed to file any written submission to the same.

5. Looking at the lackadaisical and highly irresponsible attitude of the respondent, **PIO O/o Bureau of Investigation, Punjab** is directed to show cause for not providing the information to the complainant within the statutorily period. The respondent-PIO is also directed to file a written point-wise reply in this regard before the next date of hearing with a copy to the complainant.

6. It is observed that the respondents are being represented by very low level officials who are not in a position to satisfy the commission and the appellant. From the next date of hearing, no person below the PIO or APIO will be allowed to appear in the Commission.
