ORDER:

- 1. The RTI application is dated 15.12.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.04.2022 and the second appeal was filed in the Commission on 13.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 22.08.2022. Accordingly, the case has been heard today. Shri Puneet Bansal, appellant comes present to attend the hearing in person before the Bench.
- 3. Shri Deepak, Clerk O/o Tehsildar, Abohar, District Fazilka comes present in person before the Bench to attend the hearing on behalf of the PIO. He states that reply was sent to the appellant vide letter dated 10.01.2022 and thereafter, the information has been supplied to the appellant vide letter dated 09.08.2022.
- 4. On the asking of the Bench, the appellant admits the receipt of information. He, however, expresses dis-satisfaction over the information supplied as with regard to his request for demarcation, the reply is not satisfactory. Upon this, the representative of PIO states that unless the division of land is not got done by the appellant, the demarcation cannot be done as the same cannot be done out of a joint holding of land/*Mushtarka* land and for this purpose, the appellant will have to approach the appropriate court.

5. Post deliberations, the Bench now, directs the PIO to file an affidavit on non judicial stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the demarcation cannot be done as the same cannot be done out of a joint holding of land/*Mushtarka* land and information as available in the official records in AC No.2810/2022, has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. In view of the above, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties. Copy of the letter dated 08.08.2022 is sent to the appellant along with the order.

1. The RTI application is dated 16.04.2022 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 13.04.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 22.08.2022. Accordingly, the case has been heard today through Cisco Webex. Shri Mohinder Pal Bhalla, complainant has not come present to attend the hearing.

- 3. Shri Sandeep Kumar, Employment Officer and Smt. - 5. The Bench observes that the complainant has not come present in person before the Bench nor has sent any intimation and he has also not given any contact number.
