APPEAL CASE No. 0176 OF 2021

On not receiving information from the PIO or on filing First Appeal with the First Appellate Authority (hereinafter FAA) on 28.12.2020, the Appellant filed Second Appeal in the Commission on 28.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties.

During the hearing dated 13.07.2021, the appellant stated that no information has been provided to him whereas the respondent was absent as such adjourned for 22.09.2021.

The case is fixed for today. The Appellant states that incomplete information has been provided to him whereas the respondent is absent.
