After perusing the record, considering the arguments of the parties concerned and examining the contents of the Section 2 (j) of the RTI Act, it is very much clear that any information, which is held by or under the control of any public authority becomes accessible by a citizen. Since the information is "held by or under the control" of respondent institute, which is a public authority, therefore, all citizens have a right to access the information including inspection of site and taking/drawing of the samples of the material within the ambit of Section 2 (j) of the RTI Act. They have the right to know the quality of the material used in the public works executed by Government and its agencies.

As Section 2 (j) of the RTI Act defines right to information as below :-

- (j) *"right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to—*
- (i) *inspection of work, documents, records ;*
 - (ii) *taking notes, extracts or certified copies of documents or records;*
 - (iii) *taking certified samples of material ;*
 - (iv) *obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device;*

Accordingly, I hereby direct the respondent institute to permit inspection of the site and allow the appellant to draw/take samples of the material in accordance with the procedure laid down by the Municipal Corporation, Moga. If the Municipal Corporation, Moga has not laid down any such procedure, then applicant must be allowed to take samples of the material used as per procedure laid down by the Punjab Public Works Department (B & R) for drawing of samples of Government works.
