

"It is a long standing case having been transferred from the Bench of Prof. Viney Kapoor Mehra who has demitted the office in the Commission. From perusal of the file, it is suggested that a show cause notice for imposition of penalty has already been issued for willful suppression of information on the PIO O/o Director, Public Instruction (Colleges), Punjab.

The Commission is intrigued that despite the express directions and issue of show cause notice, no tangible action has been taken by the respondents. Therefore, once again, the PIO is directed to provide a lucid response/reply to the information seeker under intimation to the Commission, failing which penal consequences shall follow. Be it noted that no further opportunity shall be afforded."

The Commission considers him to be a deemed PIO and desires him to provide the information of the estimates of the works along with entries in the Measurement Book to the information seeker within 10 days positively from the receipt of this order, failing which it shall be considered as a willful obstruction of flow of the information and the penal consequences shall follow."

"Shri Hakam Singh, BDPO Sri Muktsar Sahib has come present to represent the Junior Engineer. He submits that in compliance with the order passed by the Commission, a copy of the cross-section of the work done, as submitted by the Junior Engineer, has been provided to the appellant. We have seen it. It does not fulfill the technical requirement of describing the details in terms of the measurement of the work executed. The Commission is also intrigued to find that the Measurement Book as on date despite the work having been completed about a month ago, has not been written. While directing the BDPO to provide the details of the cross-section, as discussed above, the Commission desired the Director, Rural Development & Panchayats, Punjab to look into this serious irregularity and take appropriate action."

"The case has come up today. Sh. Iqbal Singh, A.E, has come present and says that the technical details available on the Measurement Book have been provided to the information seeker. However, the details of the bills and vouchers are with Panchayat Secretary who is on leave due to indisposition of his son. Sh. Iqbal Singh, A.E, assures that as soon as he joins, he would arrange to provide the copies of the documents to the information seeker.

The Commission underlines that this is a long standing case any further delay by the Panchayat Secretary in providing the information shall invite the imposition of

The appellant is seeking information about the documents attached with the nomination papers filed by one Shri Balram Singh with the Returning Officer of Gram Panchayat, Karnana, Block Banga, District SBS Nagar (Nawanshahar) for the election of a Panch held during the year 2018.
