ORDER

This order may be read with reference to the previous order dated 25.10.2018.

2. Today again no one has appeared on behalf of the Respondent.
3. The appellant states that no information has been given to him so far.
4. After hearing the Appellant, it is observed that no information has been given to the appellant so far. Today is the fifth hearing of the case and till date no one has appeared on behalf of the Respondent. This shows that the Respondents has no regard for the orders issued by the Commission. This is indeed a serious matter. The perusal of the file shows that the appellant filed RTI on 26.12.2017, but the respondents have not given any information after lapse of more than six months. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.2500/- (Rupees Twenty Five Hundred Only)** is awarded to the Appellant as compensation. I order accordingly.

4. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission
7. Last opportunity is given to the ***PIO O/o SDM-cum-Licensing and Registering Authority, Patti, Tarn Taran***, to appear before the Commission and state his case failing which action under Section 20 (1) of the RTI Act 2005 will be initiated.
