On the last date of hearing, held on 06.09.2021;

He also intimates the Commission that in compliance to the order dated 06.09.2021 the requisite information has again sent to the appellant vide letter no. 3455 dated 16.09.2021, and a reply has also been sent to the Commission which has been received in the Commission vide Diary No 22144 dated 29.09.2021.
