Further as per Section 8(1) (h) of RTI Act, 2005 not with standing any thing contained in this act, there shall be no obligation to give any citizen, information which would impede the process of investigation or apprehension or prosecution of offender. Though the investigation or apprehension part of the aforesaid provision is no more applicable, yet the prosecution is likely to be affected adversely in case the information sought is revealed to the applicant.

Therefore information cannot be provided to the applicant in appeal case no 4202 of 2021."
