6. Respondent PIO is directed to send attested copy of identified 16 pages along with forwarding letter to the appellant by tomorrow i.e. 23.11.2022 through registered post with a copy to the Commission through email.
7. After having detailed discussion with both the parties and examining the case file, respondent PIO is also directed to forward the appellant's pension case to the concerned office within twenty (20) days after receipt of this order under intimation to the Commission.
