1. This order may be read with reference to the order dated 18.10.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Chanderdeep Maggu, appellant has not come present to attend the hearing in person or through cisco webex.

It be further stated that the information relating to voucher files as sought by the appellant, have not been handed over to the present Panchayat Secretary, Shri Surja Ram by previous Panchayat Secretary, Shri Balwinder Singh who is presently under suspension. It be also stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. In view of the submissions made by the PIO O/o BDPO, Fazilka before the Bench, the show cause notice issued to the PIO on 19.01.2022 is dropped.

**ORDER:**

1. This order may be read with reference to the order dated 18.10.2022 passed by this Bench on the previous hearing..
2. The case has been heard today. Shri Dilawar Singh, appellant comes present to attend the hearing in person before the Bench. He states that he has not been provided any information.
3. Shri Gulshan Kumar, Assistant Environmental Engineer PIO O/o Punjab Pollution Control Board, Ropar comes present to attend the hearing in person before the Bench and states that he has brought along the written submissions of PIO to the RTI application. He hands over a copy of the same to the appellant in the court itself and also produces a copy before the Bench. He also states that he had visited the site mentioned in the RTI application and found that there is Broiler Breeding Farm in place of poultry farm and the owner of the said could also not be met there.
4. The Bench directs the appellant and the respondent to sit together in the adjacent court room and the respondent is directed to explain to the appellant the details of information supplied. Post meeting, both the appellant and respondent report back. Though the appellant admits receipt of requisite information, he, however, alleges massive corruption in the PPCB office, Ropar, especially by the PIO.
5. The Bench is convinced that requisite information stands supplied to the appellant and looking at the allegations of corruption made by the appellant, directs him to take up the matter at an appropriate level i.e. Vigilance Department etc.
6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.

**ORDER:**

1. The RTI application is dated 18.07.2022 vide which the appellant has sought information as enumerated in his RTI application.
