ORDER:

(To be read in continuity with earlier orders on 1.11.2019, 20.12.2019, 13.2.2020, 30.7.2020, 1.10.2020, 20.11.20, and 4.8.2021)

1. The RTI application is dated **20.3.2019** vide which the appellant has sought information **regarding work orders and tenders passed in the house meetings of Zirakpur Municipal Council**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **26.6.2019** and Second Appeal was filed in the Commission on **27.8.2019** under Section 19 of the Right to Information Act, 2005. The case was last heard on **4.8.2021**.
2. The appellant is absent. At the last hearing on 4.8.2021, the respondent PIO was served a Show Cause Notice for delaying/denying the requested information and falling to attend four successive Hearings. The respondent-cum-Executive Officer, Sh. Girish Verma, has submitted a detailed reply to the Show Cause Notice vide Memo No. 789 Dated 20.12.2021. In said reply, the respondent has stated that as per orders of the Commission, the respondent was allowed to inspect the record on 23.12.2019 and after the inspection he was supplied 1141 pages out of which 200 pages was supplied free. The remaining 941 pages were charged at Rs. 2/- per page and the appellant received the complete 1141 pages under his signature on 23.12.2019.
3. At the last hearing on 30.7.2021, the appellant informed this Commission that he has received 1141 pages, but some of the pages are illegible and some are missing. Following, this the Commission requested the appellant to list deficiencies to the respondent PIO with a copy to this Commission. As per the respondent, the appellant did not communicate any deficiency.
