

- 3. The representative of the respondent submits that the appellant has sought the action taken on the complaint filed by him to the Deputy Commissioner. He further submits that the appellant has sought the information from the Public information Officer office of the Deputy Commissioner, Ludhiana who has transferred the said RTI application to the District Development and Panchayats Officer. He further submits that the complaint of the appellant has already been sent to the Block Development and Panchayats Officer, Ludhiana -1. He further submits that the Block Development and Panchayats Officer, Ludhiana -1, has not taken any action on the said complaints so far. He has also sent the correspondence in this regard, which is taken on record.
- 4. However, the appellant submits that no action is being taken by the department on the complaint filed by him on 3 July 2021. He further requests that the directions may be issued to the respondent authority to take appropriate action on the matter at the earliest.
- 5.
