ORDER:

1. The complainant, **Satnam Singh Dhawan**, filed this RTI application dated **16.2.2021** and sought information **regarding construction of bathrooms under the Ludhiana Smart City Project**, from the **PIO o/o Municipal Corporation, Ludhiana**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **15.11.2021**. Notice was issued to the parties for first hearing in the Commission on **22.4.2022**.

2. The complainant is absent. The respondent PIO, represented by Deepak Gupta, Senior Engineer from the Smart City Project Zone D, Ludhiana, reiterated the reply sent to the complainant vide Letter No. 1690 Dated 2.3.2021, wherein he had been informed that no "bathrooms" have been constructed under the Smart City city project, Ludhiana.

3. The respondent PIO is evidentially trying to evade the information sought in this RTI application by insisting that the complainant has used an "incorrect" term. However, the complainant in using the term "bathroom" very clearly means to ask about public toilets constructed under the Ludhiana Smart City Project.

4. The Commission takes a very serious view of the PIO's conduct and directs him to provide the requested details by way of the total number of public toilets / conveniences constructed as part of the Smart City Project since its inception. This information must be submitted to the Commission within ten days of receipt of this Order.
