2. Both parties are present. The respondent PIO-cum-Superintendent from Property Tax Branch, Zone B, Sh. Rajiv Bhardwaj, in a reply to the appellant vide Letter No. 257 Dated 13.4.2022 has informed him that the information pertains to property belonging to a third party who has refused disclosure to the appellant. The appellant was informed vide Letter No. 145 Dated 5.5.2021. Subsequently, the First Appellate Authority, on 6.7.2021, also upheld the respondent PIOs decision.
3. This Commission has examined the RTI application, the Second Appeal filed by the appellant and the reply submitted by the respondent PIO. The respondent PIOs decision to withhold the requested information as third party information is herewith upheld.
