ORDER

The RTI application is dated 4.3.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 17.3.2021 and second appeal was filed in the Commission on 30.4.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant states that no information has been provided by the respondents so far. He further requested that the directions be issued to the respondent-Public Information Officer to supply the complete information. However, the representative of the respondents states that the information concerning the RTI application of the appellant cannot be supplied under Section 8(1)(h) of the RTI Act, 2005. He also states that the written submission in this regard has already been sent, which is taken on record.

3. The reply of the respondent-Public Information Officer is not tenable as the appellant has sought the copies of the letters/noting written to his parent department regarding his service along with the copy of dispatch register and receipt of the registry thereof.

4. Accordingly, the respondent-Public Information Officer is directed to supply the complete information to the appellant before the next date of hearing under intimation to the Commission.
