ORDER

The RTI application is dated 18.3.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 26.5.2020 and second appeal was filed in the Commission on 31.7.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information as per his RTI application:-

2. ਮੌਜੂਦਾ ਸਰਕਾਰ ਦੇ ਕਾਰਜਕਾਲ ਦੌਰਾਨ ਸਾਰੇ 117 ਵਿਧਾਇਕਾਂ ਦੀ ਹਾਜਰੀ ਰਿਪੋਰਟ ਸਬੰਧੀ ਤਸਦੀਕਸੁਦਾ ਦਸਤਾਵੇਜ ਉਪਲਬੱਧ ਕਰਵਾਏ ਜਾਣ।

3. ਮੌਜੂਦਾ ਸਰਕਾਰ ਦੇ ਕਾਰਜਕਾਲ ਦੌਰਾਨ ਸਾਰੇ 117 ਵਿਧਾਇਕਾਂ ਦੀਆਂ ਤਨਖਾਹਾਂ, ਭੱਤੇ ਅਤੇ ਹੋਰ ਖਰਚਿਆ ਦੇ ਬਿੱਲ ਜੋ ਆਪ ਜੀ ਵੱਲੋਂ ਪਾਸ ਕੀਤੇ ਗਏ ਦੀ ਜਾਣਕਾਰੀ ਦਿੰਦੇ ਤਸਦੀਕਸ਼ੁਦਾ ਦਸਤਾਵੇਜ ਉਪਲਬੱਧ ਕਰਵਾਏ ਜਾਣ।

4. ਮੌਜੂਦਾ ਸਰਕਾਰ ਦੇ ਕਾਰਜਕਾਲ ਦੌਰਾਨ ਵਿਧਾਨ ਸਭਾ ਨੂੰ ਚਲਾਉਣ ਦਾ ਹੁਣ ਤੱਕ ਕੁੱਲ ਕਿੰਨਾ ਖਰਚਾ ਹੋਇਆ ਸਮੇਤ ਸਾਰੇ ਮੁਲਾਜਮਾ ਦੀਆਂ ਤਨਖਾਹਾਂ ਦੀ ਜਾਣਕਾਰੀ ਦਿੰਦੇ ਤਸਦੀਕਸ਼ੁਦਾ ਦਸਤਾਵੇਜ ਉਪਲਬੱਧ ਕਰਵਾਏ ਜਾਣ।

3. The appellant states that the respondent-Public Information Officer may be directed to supply the complete information with regard to his RTI application. However, the respondent-Public Information Officer submitted his reply vide No. 24/Public Information Officer/2020/13531 dated 16.9.2020 and also sent an email dated 21.9.2020, which are taken on record. In the said letter dated 16.9.2020, it has been stated that no such information is available in the form of report and regarding Point No. 4 of the RTI application it has been stated that no such information is required to be maintained separately. Even it has been clarified that no separate expenditure is incurred by the Punjab Vidhan Sabha for the purpose of session of Vidhan Sabha. The respondent-Public

Information Officer reiterates his reply and also states that the information pertaining to Point no. 1 and 3 has already been supplied.

4. Regarding attendance of MLAs, Point No. 2 of the RTI application, the respondent-Public Information Officer has also placed on record a copy of the decision given by the Hon'ble Punjab and Haryana High Court vide CWP No. 26288 of 2018, titled as "Aseem Takyar Vs. State Information Commission, Haryana and ors" has dismissed the writ petition against the decision of the SIC, Haryana, for denying information regarding attendance of MLAs of Haryana Vidhan Sabha. The bench of Hon'ble Chief Justice In LPA No. 1170 of 2019, has also dismissed the said LPA on 26.8.2019. It has also mentioned in the said reply sent through email dated 21.9.2020 that the subject cited appeal being similar as that of Haryana Vidhan Sabha.

5. In addition the respondent-Public Information Officer also categorically mentioned regarding Point No. 4 of the RTI application that the information is voluminous and will divert the resources of the organization and requests that in accordance with the decision given by the Hon'ble Supreme Court of India in Civil Appeal No. 6454 of 2011 (Arising out of SLP (C) No. 7526 of 2009) date of disposal 9.8.2011 – Central Board of Secondary Education and another Vs Aditya Bandopadhyay and others, the case may be closed.

6. After hearing both the parties, going through the judicial pronouncements and the case file, the Commission accepts the plea taken by the respondent-Public Information Officer and observes that no more action is required to be taken in this case. Hence, the case is disposed of and closed. A copy of the decisions mentioned herein is appended with this order.

ORDER

Present:-

The RTI application is dated 2.11.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 9.3.2020 and second appeal was filed in the Commission on 27.7.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The appellant states that the respondents are not providing the information as per his RTI application. Whereas, the representative of the respondents states that the information is not specific so they are unable to trace the record. He further states that the appellant has already been informed in this regard vide letter No. 3453 dated 3.12.2019 and a copy of letter sent to the appellant has been submitted to the Commission, which is taken on record.

4. After hearing both the parties, going through the record available on the case file, the Commission observes that the appellant has not sought the specific information so no further action is required in this case. Therefore, the case is disposed of and closed.
