The respondents stated that the appellant is habitual of filing RTI applications on the same matter again and again.

The Commission has received a mail sent by the appellant in which he has mentioned names of 13 persons whose information has not been received. A photocopy of the said list is handed over to Shri Kulwant Singh, DEO (SE). Fazilka with a direction that the appellant is seeking the attested copies of SC/ST Certificates of concerned persons and attested copies of concerned certificates be sent to the appellant through registered post within 15 days.

The respondents further stated that they have written letters to the concerned persons for getting their consent to provide information regarding their certificates and they replied not to provide their information to the appellant.

I have discussed the matter with the respondents. The information regarding SC/ST certificates is not a personal matter rather these certificates are issued by the public authority/public servants under specific law. So, these certificates are public documents and not personal information of the concerned persons.

So, the respondents are directed that information sought by the appellant be sent to him through registered post within 15 days and come present personally on the next date of hearing along with copy of information and copy of postal receipt.
