ORDER

This order may be read with reference to the previous order dated 08.01.2020 vide which show cause notice for imposition of penalty and award of compensation was issued for his absence and for not supplying the information to the appellant.

2. The appellant states that no information has been provided by the respondents to him till date.

3. The respondent-PIO states no intimation for hearing was ever received by him. Hence, he could not appeared on the previous dates of hearing dated 11.12.2019 and 08.01.2020. Keeping in view this position in view, show cause notice issued to him for his absence be withdrawn. The respondent-PIO hands over a copy of self declaration to the appellant during the hearing stating that no record is available in his office. He further states that he has sent the same through e-mail to the Commission.

4. After hearing both the parties and going through the record available on the case file, it is revealed that the appellant has sought same information from District Development and Panchayats Officer, Fazilika in AC No.829/2018 in which it is mentioned that district Fazilika came into existence in the year 2011 and the complaint was filed in the year 2010. Hence, the complaint might be available in the office of DDPO, Ferozepur. Now, DDPO, Ferozepur also gives in writing that copy of complaint is not available in their record. Accordingly, the issue of missing record in the Districts of Fazilika and Ferozepur is hereby brought to the notice of the Commissioner, Ferozepur Division, Ferozepur so as to take appropriate action as per the rules.
