First appeal was filed with the First Appellate Authority (hereinafter called FAA) and second appeal was filed in the Commission on 14.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

- 2. The appellant states that he is satisfied with the information pertaining to Point No. 1 and 6 of the RTI application. He further states that regarding the remaining points he has sent a letter mentioning the deficiencies, which is taken on record. Furthermore, the appellant states that the respondent-Public Information Officer has denied the information being 3rd party whereas it does not contain any confidential information of the 3rd party so he requested to supply the information.
- 3. After deliberations with the appellant viz a viz reply sent by the respondents, the directions are issued to the respondent-Public Information Officer to supply the information pertaining to Point No. 3 and 4 of the RTI application. However, in case any information that part of the information is exempted under Section 8(1)(j) then the same may be dealt with under Section 10(1) of the RTI Act, 2005 which are reproduced below:-
 - **"10.** (1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information. "
