5. In view of the foregoing, I find that there are glaring systemic deficiencies in the office of BDPO, Sirhind, Distt Fatehgarh Sahib. Appropriate mechanism has not been provided to keep the record properly by the public authority due to which the information / request under RTI Act, 2005 are not being served properly.

6. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.3000/- (Rupees Three Thousand Only)** is awarded to the Appellant as compensation. I order accordingly.

7. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.

Therefore the respondent was directed to file an affidavit.

2. Today the appellant is not present. He has sent a letter that he is unable to attend today's hearing.

3. The respondent states that as per directions of the Commission, an affidavit has been sent.

4. After hearing the respondent and going through the case file, it is observed that the affidavit sent by the respondent is not correct. Hence the respondent is again directed to send an affidavit mentioning therein that the information that has been supplied is true, complete and no other information relating to this RTI application is available in the record. The affidavit should be on a stamp paper duly signed by the PIO and to be provided within 15 days.
