5. The Bench clarifies to the respondent that the appellant needs information related to JD Grand Hotel, Amritsar and not JD Grand Sikh Rumala Centre owned by the same owner. The information related to JD Grand Rumala Centre was earlier and the case stands disposed off after provision of information.

6. In view of the above, the Bench directs the PIO to check up at his level and sort out the matter by calling the appellant to his office and allowing him access to the relevant official records. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

7. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing.
