### **ORDER**

This order may be read with reference to the previous orders passed by the Commission. During the last hearing the appellant filed a letter before the Commission that his appeal case filed in the Commission be treated as complaint case u/s 18(1) of the RTI act instead of appeal u/s 19(3).

2. Further, Legal opinion taken on his application, the same is as under:

*"provisions of Section 18 as well as judgment of Hon'ble Supreme Court in CIC vs State of Manipur, 2012 (AIR) SC864 have been discussed and it has been brought on record that procedure under Section 19 of RTI Act when compared to Section 18 has several safeguards for protecting the interests of the person who has been refused the sought for information. It has also been mentioned in this opinion that there is no provision in Punjab RTI Rules to entertain complaint case under Section 18 of the RTI Act. In view of the above it has been concluded that the safer option is to disposed of the appeal cases on merit and not to treat as a complaint under Section 18 which is an extraordinary provision."*

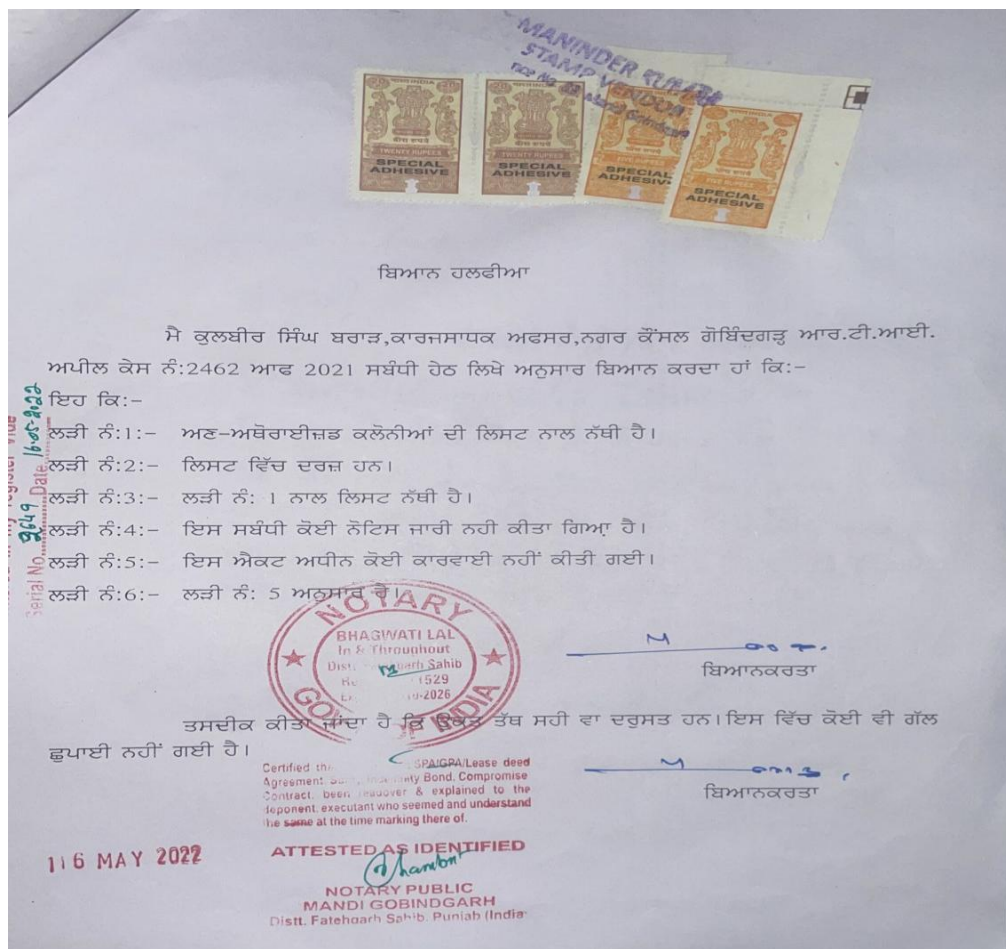
