

ORDER:

The appellant, through RTI application dated 30.04.2019, sought information regarding a copy of the application form/request dated 25.08.2015 for electric connection No.A11SA441492M alongwith copy of bills issued and other information from the office of Addl. SE (Operational), PSPCL Division Ajnala. The appellant was not provided with the information, after which the appellant filed the first appeal before the First Appellate Authority on 20.05.2019, which did not decide on the appeal. After filing first appeal, the PIO sent a reply to the appellant vide letter dated 27.06.2019. On being not satisfied with the information, the appellant filed 2<sup>nd</sup> appeal in the Commission on 21.08.2019.

The case has been heard on 30.12.2019, 17.03.2020, 04.08.2020, 15.09.2020, 09.11.2020, 09.03.2021, 18.05.2021, 31.08.2021, 29.04.2022 & 04.04.2022.

On the date of hearing on 15.09.2020, the respondent was present at Chandigarh and informed that the information has been provided to the appellant vide letter dated 03.09.2020 with a copy to the Commission. The Commission had received the copy of the information on 09.09.2020, which had been taken on the file of the Commission.

The appellant was not satisfied. After going through the information provided and hearing both the parties, the following was concluded:

Point-1 - Information provided

Point-2 - Information provided. Appellant not satisfied. The PIO to give in

writing on an affidavit that the meter number was wrongly

entered.

but the same has been corrected.

- Point-3 - PIO to give reply on an affidavit

- Point-4 - PIO to give reply on an affidavit

The PIO submitted a reply to the show-cause notice, which was taken on the file of the Commission. A copy of the order was sent to the Superintending Engineer, PSPCL Sub-urban, Circle Amritsar to inquire into the matter of mismatch of meter serial number and submit a detailed enquiry report to the Commission.

On the date of the hearing on **09.11.2020**, as per the appellant, the PIO had not provided the information. The PIO was absent, nor had compiled the order of the Commission. The PIO-Addl. SE(Operational) PSPCL Division Ajnala was directed to pay an amount of **Rs.3000/-** via demand draft as compensation to the appellant and submit proof of having compensated the appellant. The PIO was again directed to comply with the Commission's earlier order.

On the date of the hearing on 31.08.2021, the respondent informed that the compensation amount has been paid to the appellant via DD No.150838 dated 21.05.2021, and the appellant has received the same.

On the date of the last hearing on **29.03.2022.**, the respondent present pleaded that pursuance to an earlier order of the Commission, an affidavit filed by the PIO was sent to the Commission on 01.09.2021, and a copy of the same was sent to the appellant by registered post on 16.09.2021.

As per the appellant, he had not received the original affidavit from the respondent PIO.

The PIO was directed to provide a fresh affidavit to the appellant as per the earlier order and send a copy to the Commission. The PIO was also directed to file a reply to the show cause notice within three days, otherwise, it will be presumed that the PIO has nothing to say on the matter, and the commission will take penal action against the PIO under section 20 of the RTI Act.

On the date of the last hearing on **04.04.2022**, the appellant informed that the PIO has not provided the affidavit as per the order of the Commission.

The respondent had brought the affidavit. The PIO was directed to provide a fresh affidavit by mentioning all points stated in the RTI application. The PIO is also directed to file reply to the show-cause notice. The appellant was directed to collect the affidavit from the PIO by visiting their office on 05.04.2022.

Further, an enquiry was marked to Superintending Engineer, PSPCL Sub-urban, Circle Amritsar with the direction to enquire into the matter of mismatch of meter serial number and submit a detailed enquiry report to the Commission. However, no enquiry report was received. The **Superintending Engineer**, **PSPCL Sub-urban**, **Circle Amritsar** was again directed to send an enquiry report to the Commission

#### Hearing dated 23.05.2022:

#### This order should be read in continuation of the earlier interim orders.

The case has come up for hearing today through video conferencing at DAC Amritsar. The respondent present pleaded that complete information has been supplied and compensation has been paid to the appellant. The respondent also provided a fresh affidavit to the appellant during the hearing. The appellant has received the fresh affidavit as per the order of the Commission.

The enquiry report of the Superintending Engineer, PSPCL Sub-urban, Circle Amritsar, has also been received which has been taken on record.

## **Appeal Case No. 3057 of 2019**

All out efforts have been made to reconcile this case, and it has taken several hearings to reach a point where it can be concluded that all efforts have been made to help the information seeker get the information that was sought in the RTI application. In this case, even a compensation amount was awarded to the applicant for the long haul that took to mediate between the public authority and the appellant. Since the information has been provided to the best possible extent, there is no further action that is required from the commission.

The case is **disposed of and closed**.

Complaint Case No. 1276 of 2021

ORDER:

Amritsar.

The appellant through an RTI application dated 15.09.2021 has sought information regarding action taken by the department against the accused in FIR No.73 dated 17.06.2019 police station Majitha Road, Amritsar and other information as enumerated in the RTI application concerning the office of DCP Amritsar. The appellant was not provided the information after which the appellant filed a first appeal before the First Appellate Authority on 11.11.2021 which took no decision on the appeal.

Versus

The case has come up for hearing today through video conferencing at DAC Amritsar. The respondent present pleaded that they received the RTI application of the complainant dated 15.09.2021, however since the enquiry was pending, the reply was sent to the appellant vide letter dated 16.10.2021. The respondent further informed that the accused have been arrested, however since the enquiry is still pending, the information cannot be provided under section 8(1)(h) of the RTI Act and the reply has again been sent to the appellant vide letter dated 18.05.2022.

Having gone through the RTI application and hearing both the parties, the PIO is directed to provide names of the persons arrested.

Having gone through the record, the Commission observes that since this is a complainant case and the complainant has come to the Commission under the provision of Section 18 of the RTI Act, 2005 in which no directions for providing further information can be given by the Commission.

The Hon'ble Supreme Court of India in its Order dated 12.12.2011 in Civil Appeal Nos.10787-10788 of 2011 (arising out of SLP No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information.

Since there is an alternative and efficacious remedy of first appeal available to the complainant under section 19(1) of the RTI Act, 2005 which has not been availed in the instant case and the First Appellate Authority has not had the occasion to review the decision of the PIO, as envisaged under the RTI Act by passing a detailed well reasoned speaking order.

If, however, the complainant does not feel satisfied with the decision of the First Appellate Authority, he/she will be at liberty to file a Second Appeal before the Commission under Section 19(3) of the RTI Act.,2005.

# Complaint Case No. 1276 of 2021

In view of the observations noted above, the instant case is remanded back to the concerned First Appellate Authority-cum-Commissioner of Police Amritsar with a copy of the RTI application for their ready reference and is also directed to call the complainant within 15 days of the receipt of the order, provide the information/reply pertaining to this RTI application. A compliance report of the same be sent to the Commission.

With the above observation and order, the case is disposed of and closed.


